### **The Royal Television Society London Centre**

I report on the accounts of the London Centre for the year ended 31 December 2010, which are set out on pages 2-3.

#### Respective responsibilities of trustees and examiner

The centre's committee is responsible for the preparation of the accounts. The centre's committee considers that an audit is not required for this year (under section 43(2) of the Charities Act 1993 (the 1993 Act)) and that an independent examination is needed.
